- 1.) Roll Call: Commission members Julie Etheredge, Jeanine Johnson, Brian Hayes, and Michael Mahncke were present, as well as city staff member Iris Lehmann.
- 2.) Approve the Minutes of the June 11, 2019 regular meeting: Chair Etheredge opened the meeting at 5:35 PM and asked if there were any corrections or additions on the Minutes from the June 11, 2019 meeting. Brian moved to approve the Minutes as is. Mike seconded the motion. The motion was approved unanimously.

3) Old business:

a. Ongoing projects:

- i. <u>Fairview Cemetery Tour</u>: Iris had spoken with the Channel 15 crew about the project. They had found an intern to help edit the film and anticipate finishing the piece this summer.
- ii. <u>Update on the CLG Grant for the Wild District Nomination:</u> Jeanine and Susan Card attended the State Nominations Review Committee meeting. Jeanine reported on her experience. Once the Minutes from the meeting are released the nomination can be forwarded on for the next and final level of review.
 - Iris handed out timesheets to the Commission members. She asked that they fill out and submit the forms to her by their next meeting so that she can start the close out documents for this CLG grant.
- iii. Upcoming CLG grant opportunity- Iris reported that she had been in contact with Leah from Tallgrass Archeology about the potential survey of the Overman Park area. It was recommended that the commission apply for a "reconnaissance survey". Leah suggested this type of project because it can cover a larger area, as is desired by the Commission. Iris shared a drafted boundary map she created for the potential study area. Iris added that she had asked Leah for a cost estimate for this type of project and will let the Commission know what she hears back. With the deadline for submission for this upcoming round coming up in September Iris noted that ideally the Commission and Staff would be working on the grant application through August.

4) New business:

- a) <u>Commission Elections</u>. The Commission agreed to wait until Meridith was present to vote on this item.
- Review of at-risk and newly identified historically significant buildings and or sites: Updates were given on a number of ongoing projects in the Community.
- 5) Other items

She noted that the cemetery film may not be finished in time and urged the group to start considering other options. The Commission shared ideas. It was agreed that at the next meeting there would be a vote and a project to two will be chosen.

- 6) The next meeting date: The next meeting was discussed. Due to upcoming vacations of staff and Commission members the Committee agreed to rescheduled their regular meeting from Tuesday, August 13th to Tuesday, July 30th at 5:30 PM.
